

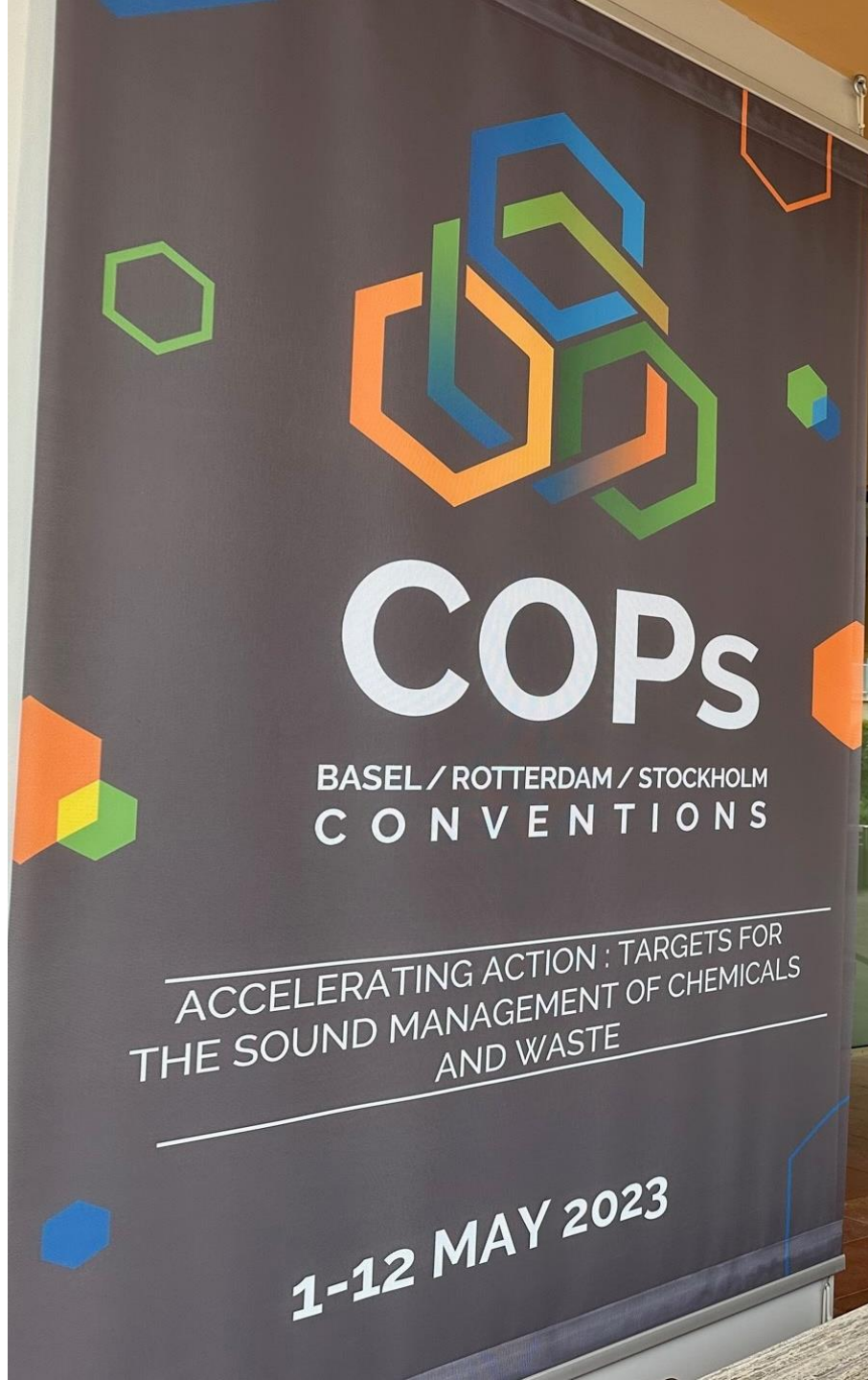

BASEL CONVENTION

COP-16

Main outcomes

- **Adoption of Technical Guidelines:**

- Technical guidelines on **environmentally sound management (ESM) of plastic wastes**
- Technical guidelines on **ESM of POPs wastes**
- Technical guidelines on transboundary movements of **electronic and electrical waste and used electrical and electronic equipment** (on interim basis)
- Further work to take place on: Technical guidelines on **waste lead-acid batteries, other batteries and pneumatic tyres**

- **Improving the PIC procedure:**

- Small intersessional working group (SIWG) to improve the PIC procedure
- Extended the work on electronic approaches to notification and movement documents

- **Strategic framework:**

- SIWG to develop a new strategic framework



Main outcomes (cont.)

- **Further legal clarity:**
 - Extended work on review of annexes aimed at further clarifying the disposal operations and hazardous wastes covered by the Convention
- **Implementation and Compliance Committee:**
 - Adopted recommendations to improve Parties' compliance with a range of obligations, including progress achieved to reach national reporting targets
 - Adopted POW for 2024-2025, including work to integrate the Convention's implementation in development frameworks
- **Partnership Programme:**
 - Reviewed progress and extended the work of the **Partnership for Action on Challenges relating to E-waste**, the **Environmental Network for Optimizing Regulatory Compliance on Illegal Traffic (ENFORCE)**, the **Partnership on Plastic Wastes** and **Household wastes Partnership (HHW)**
 - HHW to revise the overall guidance document on ESM of household waste
 - Subscription fee system withdrawn



Main outcomes (cont.)

- **Cooperation with the World Customs Organization (WCO):**
 - Information invited to assist the Secretariat in facilitating the inclusion of BC wastes in the Harmonized System (HS) Codes, as per decision BC-14/9
 - Secretariat to continue to develop proposals for amending HS Codes and facilitating review of proposals, taking into account information received
 - **National reporting:**
 - Importance of information provided in national reports for measuring progress towards SDGs
 - OEWG-14 to consider wastes stream for which guidance on inventory would be useful, based on Parties' proposals
 - **E-wastes amendments:**
 - Secretariat to prepare draft updates to 11 guidelines, factsheets, manuals to reflect adjustments consequential to adopted e-wastes amendments

Main outcomes

Listing of chemicals in Annex III

- The COP amended Annex III to list:
 - **Terbufos (pesticide)**
- Amendment will enter into force for all Parties on 22 October 2023
- Chemicals listed in Annex III are subject to the PIC procedure

Enhancing the effectiveness of the Convention

- Work was launched to enhance the Convention's effectiveness by addressing the impacts regarding the listing of chemicals in Annex III and its implementation
- Proposal to amend the Convention was not accepted

Main outcomes (cont.)

- **Compliance Committee**

- Adopted the **programme of work of the Committee** for 2024-2025
- Invited **Parties to make specific submissions** to the Compliance Committee
- Encouraged Parties to submit responses to its questionnaire on **issues faced by Parties in relation to notifications of final regulatory action**

- **Implementation of the Convention**

- Encouraged Parties to **ensure the effective operation** of the Convention
- Encouraged Parties to provide the Secretariat with **information** that might assist other Parties to **prepare and notify final regulatory action**





STOCKHOLM CONVENTION

COP-11



Main outcomes

- **Adoption of Procedures and Mechanisms on Compliance**
 - To assist Parties in fulfilling their obligations under the Convention (systemic issues of interest to all Parties and challenges faced by individual Parties)
 - Compliance Committee established; members to be elected at COP-12
- **Launch of Report on the 2nd Effectiveness Evaluation**
 - Convention provides an effective and dynamic framework for regulating POPs throughout their life cycle; progress has occurred since the first evaluation in 2017
- **Adopted the Global Monitoring Results**
 - Regulations targeting POPs have succeeded in reducing levels of POPs in humans and in the environment
- **Endorsement of a New Regional Centre**
 - SCRC Trinidad and Tobago



Main outcomes

Listing of chemicals in Annex A

- The COP amended Annex A to list:
 - **Methoxychlor without specific exemptions**
 - **Dechlorane Plus with specific exemptions**
 - **UV-328 with specific exemptions**
- Chemicals listed in Annex A may no longer be produced, used, imported and exported by Parties to the Convention

Labelling

- The COP requested the POPs Review Committee to make recommendations regarding options for identifying POPs in stockpiles, products and articles in use and in wastes

Took stock of progress in eliminating PCBs

- The COP urged Parties to meet their obligations towards 2025 and 2028 deadlines, while recognizing specific needs and challenges of developing countries



DECISIONS ON JOINT ISSUES

Main outcomes

- **Strengthened mandate for international cooperation** to address the triple planetary crisis including with UNEP (e.g. new plastics treaty, science-policy panel, 10-YFP on SCP, SAICM and UNEA-6), Minamata Convention, CBD, MP, UNFCCC and IOMC organizations
- New activities to **combat illegal traffic and trade in hazardous chemicals and wastes**
- Explore the development of a **non-State actor resource mobilization strategy**
- Conventions' **budgets/POWs** for 2024-25 approved with an approximate 4% increase
- Adoption of amendments to the MoUs between UNEP, FAO (for RC) and the COPs
- Agreement to hold **next meetings of the Conferences of the Parties** to the Basel, Rotterdam and Stockholm conventions from 28 April to 9 May 2025 in Geneva with a **high-level segment**

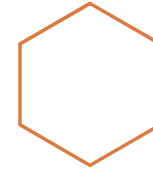
