Translation of information notified pursuant to Articles 3 (national definitions), 4(1) (import prohibitions) and 13 (2) (transmission of information) <p>This concept note focuses on the <u>Strategic Framework for the implementation of the Basel Convention 2012-2021</u>. The Strategic Framework is essential to guide the implementation and enforcement of the Convention by parties in the coming decade. Adequate implementation of the Strategic Framework contributes to achieving the objectives of the Convention.</p> | | |

Collect data, based on feedback received from parties, and maintain a database on the progress in relation to the Strategic Framework for the implementation of the Convention for the purpose of the COP-13 mid-term evaluation; 2. Facilitate actions to mobilize financial resources for the Strategic Framework implementation; 3. Cooperate closely with parties, BCRCs and other stakeholders to support the development and implementation of the activities set out in the Strategic Framework. | | |
